PUBLIC HEARINGS

1. **SD2021-0005/SR2022-0002/VAR2022-0003: Juan Hernandez – Brookfield Properties (MFH CM LLC): Request for an amended Tentative Map for the medical portion, and a Vesting Tentative Map, Design Permit, and Minor Exception for the development of the residential portion, also referred to as "Rosewood", of the Lillian Commons medical campus mixed-use project. The amending Tentative Parcel Map will amend the approved Tentative Parcel Map SD2019-0007. The proposed Vesting Tentative Map and Design Permit are for the development of a 120-unit residential project that consists of 34 single-family attached duet homes, 86 townhome-style condominiums, associated utilities and infrastructure, and approximately 1.98-acres of park space within the project boundaries. The Minor Exception request is to allow a maximum building height of 38 feet 6 inches. The properties, identified by Assessor Parcel Numbers 817-09-039 thru 041, are located on the southeast quadrant of Juan Hernandez Drive and Barrett Avenue (BFH CM LLC, Owner).**
